 - c. Wind zones: Up to and including high as defined in NZS 3604:2011
 - d. Climate zones: Up to and including 3 as defined in the New Zealand Building Code
 - e. Ground bearing capacity: Good ground as defined in B1 Structure Compliance Document
 - f. Roofing finish: Colorsteel Endura or Colorsteel Maxx
 - g. Corrosion zone: Up to and including Zone D as defined in NZS 3604:2011, except where adverse microclimatic factors e.g. geothermal
