- 2. This National Multiple-Use Approval includes the Permitted Variations set out in this Schedule.
- 3. Minor variations in accordance with Building (Minor Variations) Regulations 2009 are permitted.
- 4. Mirror images of the floor plan are permitted.
- 5. Foundations are not included as part of this approval.
- 6. The building is to be located no closer than 1.0m from the relevant boundary.
- 7. The building must be connected to a potable water supply and must be connected to a sewer or foul water disposal system.
- 8. This National Multiple-Use Approval can only be used where the following conditions apply:
 - a. Seismic zones: Limited to sites in earthquake zones 1 and 2, and in subsoil classes A to D as defined in NZS 3604:2011.
 - b. Snow Loading: Limited to sites with a maximum ground snow load of 1.0kPa as defined in NZS 3604 2011.
 - c. Wind zones: Limited to sites with an Ultimate wind speed of 50m/s (Very High) as defined in NZS 3604;2011.
 - d. Climate zones: Limited to sites up to and including Zone 3 as defined in NZS 4218:2009.
 - e. Exposure zone: Limited to sites up to and including Zone D as defined in NZS 3604:2011. Except where adverse microclimatic factors (e.g. geothermal areas)
