  - c. Wind zone: Limited to sites up to and including High as defined in NZS 3604:2011
  - d. Climate zones: Up to and including Zone 2 as defined in NZS 4218:2009\*
  - e. Exposure zone: Up to and including Zone B as defined in NZS 3604:2011. Except where adverse microclimate factors (e.g. geothermal areas)
  - f. Ground bearing capacity: Good ground as defined in B1 Structure Compliance Document
