2. If there are any changes to the approved plans and specifications this National Multiple-Use Approval does not apply.
3. Minor variations to the design as defined in the Building (Minor Variations) Regulations 2009 are permitted; and must be assessed at the building consent stage.
4. Foundation design is not included in this National Multiple-Use Approval.
5. The building must be connected to a sewer or foul water disposal system and connected to a portable water supply.
6. The building must be located no closer than 1.000m from the relevant boundary
7. This National Multiple-Use Approval can only be used where the following conditions apply:
  - a. Wind zones: Limited to sites up to and including Medium wind zone (37m/s) as defined in NZS 3604:2011
  - b. Seismic zones: Limited to sites in earthquake zone 1 and in subsoil classes D & E as defined in NZS 3604:2011
  - c. Exposure zone: Up to and including Zone C as defined in NZS 3604:2011, except where adverse microclimatic factors (e.g. geothermal)
  - d. Climate zones: Limited to sites in Zone 1 as defined in NZS 4218:2009
  - e. Snow Loading: Not considered
