3. Minor variations to the design as defined in the Building (Minor Variations) Regulations 2009 are permitted; and must be assessed at the building consent stage.
4. Mirror images and flipped or handed images of the floor plan and roof plan are permitted.
5. The design of the foundations are to be confirmed and included in the application for building consent
6. The building is to be located no closer than 1.0m from the relevant boundary.
7. The building must be connected to a potable water supply and must be connected to a sewer or foul water disposal system.
8. Compliance schedule information is to be confirmed and included in the application for building consent for the Communal Residential use
9. This National Multiple-Use Approval can only be used where the following conditions apply:
  - a. Wind zones: Limited to sites up to and including Extra High wind zone excluding lee zones as defined in NZS 3604:2011.
  - b. Seismic zones: Limited to sites in earthquake zones 1 to 3, and in all subsoil classes as defined in NZS 3604:2011.
  - d. Exposure zone: Up to and including Zone D as defined in NZS 3604:2011. Except where adverse microclimatic factors (e.g. geothermal areas)
  - e. Climate zones: Up to and including Zone 3 as defined in NZS 4218:2009.
  - f. Ground bearing capacity: Good ground as defined in B1 Structure Compliance Document or as determined on site and incorporated in the SED foundation design.
