 - b. Seismic zone: Limited to sites up to and including Earthquake zone 4 as defined in Figure 5.4 of NZS 3604:2011.
 - c. Site subsoil classification: Limited to Class D as determined in accordance with 5.3.3 of NZS 3604:2011.
 - d. Exposure zone: Limited to sites up to and including Zone C as defined in 4.2.3.3 of NZS 3604:2011. Excludes all microclimatic conditions.
 - e. Climate zone: Limited to sites up to and including Zone 6 as defined in H1/AS1
 - f. Snow Loading: Limited to a maximum 1.5kPa ground snow load as defined in NZS 3604:2011.
